3. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by

the Board.

4. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.

5. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations

prescribed by the Board from time to time.

6. It will continue to pay an Annual Fee of Rs. 3000/- p.a. The schools run by KV/ KVS/ NVS/ Army/Navy/Air Force/Military/ Govt./Govt. Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee by D.D. in favour of Secretary, CBSE, payable at Delhi. This may be complied in future. 7. Annual fee has been received upto 31/03/2017.

8. Trained and qualified PGTs should be appointed for the subjects in which the upgradation to +2 stage has been accorded before commencement of Senior Secondary

Level Classes.

9. The school is required to submit the latest copy of Certificate of Health and Sanitary conditions, Fire Safety and Safe Drinking Water issued by the Competent Authority within 03 months.
